MINUTES OF THE ANNUAL GENERAL MEETING 2018

Held in the Old Combination Room, Trinity College, on Monday 2 July 2018

1. The Chairman welcomed members of the Society to the AGM.

Apologies for absence were received from Janice Adams, Janet Fairweather, Val Hunter, Evelyn Lord, David Smith, Matilda Watson, Lesley Williams and Michael Young.

- 2. Those present stood in memory of Peter Spufford, President of the Society, who died on 18 November 2017.
- 3. The *minutes* of the AGM held in 2017 were approved and signed.
- 4. Reports were received from the Chairman, General Editor and Dr Saunders (Sales).

Members were encouraged to help with sales of past volumes and Martin Lawrence offered to help liaise with the Northamptonshire and Bedfordshire Record Society to publicise the back stock. Wisbech and Fenland Museum offered to sell volumes on a sale or return basis.

5. The *audited accounts* for 2017 were accepted.

Mr John Dix was thanked for examining the accounts. He was reappointed as auditor for 2018.

- 6. Elizabeth Stazicker was re-elected as Chairman, Mr William Franklin was elected as Treasurer, Matilda Watson was elected as a committee member, and the other officers and members of the committee were re-elected. The position of President is vacant and the Committee will recommend a name to the next AGM.
- 7. The Chairman thanked the Master and Fellows of Trinity College for making it possible to hold the AGM in the Old Combination Room and for so generously providing the refreshments.

There being no further business, the meeting was closed.

The AGM was followed by a talk by Philip Saunders, 'From record type to digital byte: 200 years of publishing Cambridgeshire historical records'.

GENERAL EDITOR'S REPORT

As announced at last year's AGM, William Franklin's edition of *The Parliamentary Surveys* of the Cambridgeshire Properties of the Dean and Chapter of Ely 1649–1652 did indeed safely appear at the end of the year as our volume for 2018. We owe him our thanks for filling an impending gap in publications so efficiently and expeditiously. The only volume currently still certainly in play is the long-promised Huntingdonshire Hearth Tax volume. I shall be meeting with the current Chair of the British Record Society, Dr Amy Erickson, once I surface from examining and hope to be in a position to report where we are at with the volume at the AGM.

As I said this time last year, having no *certain* proposals thereafter is a worry, given the long lead-in time required. A further maps project has been mooted, and there may be printed material out there that merits republication. The General Editor has a couple of projects in mind for the middle term (which is to be interpreted as years rather than months).

And so I end with my invariable plea: suggestions of texts for publication, preferably (but not necessarily) with an editor already attached, would be very welcome.

SALES

Sales of back volumes (i.e. ignoring maps for the moment) in 2018 were much the same as they have been for many years, 36 being sold (compared to 22 in 2016, 31 in 2017). Sales of *Jonas Moore's Mapp* (published 2016) predictably began to tail off, with just 16 copies sold (75 in 2016, 31 in 2017). Fifteen copies of the other map publications were sold, fewer than previous years, as stocks of *Baker's Map of Cambridge* and of *Cambridge Maps Portfolio* are virtually exhausted (or so I thought, but a few more of the latter have since come to light), so the Archives searchroom at Shire Hall and Library's Cambridgeshire Collection, steady outlets for many years, have not been able to purchase any.

Sales of the *Cambridgeshire Committee for Scandalous Ministers*, published mid-2017, were disappointing but it may yet achieve it just deserts as it is reviewed and becomes better known. A special offer flyer for this and *Jonas Moore's Mapp* was included in the Cromwell Association newsletter *The Protector's Pen* but disappointingly, despite a complimentary review of the former in the Association's journal, the response barely paid for printing them. That we managed to slightly exceed last year's volume sales was largely down to selling at several conferences, particularly the special CAS conference at Ely, held in memory of Anne Holton-Krayenbuhl, when four copies of her edition of *Topography of Medieval Ely* were sold. Five copies of *Isleham Church Book* were sold thanks mainly to the Archivist of the Strict Baptist Historical Society circulating a digital flyer to his fellow members, demonstrating the value of particular contacts for particular titles.

Trade sales were once again confined to the main library suppliers, almost all other sales not by personal contact coming through the internet, notably *Amazon* (nine transactions) with just a couple via *Genfair*. From November, thanks to revision of the website by Liam Franklin (undertaken without charge), it became possible for the first time to buy online through our own website, paying either by bank transfer or using *Paypal*. There were some teething troubles, mainly with overseas purchases, but by the end of the year we had sold five volumes this way and one briefly hoped this would presage a boom in sales, but 2019 has not so far justified this optimism.
